

GENERAL INFO

ENROLMENT FEE:

There is an annual enrolment fee of \$65. This fee covers Administration, Insurance and Studio overhead. It is non-refundable. Please read our Terms and Conditions of Enrolment located on Page 5.

DANCE CLASS FEES:

Lighthouse Studios offers a FREE TRIAL CLASS for new students (one class only). Dance class fees are paid per term and must be paid within 7 days. If fees are not paid by the due date, the student will incur a \$25 late fee per week until fees are paid. Please refer to the Dance Class Fee Information for full pricing details.

DANCE CLASS AGE GROUPS:

TINY TOTS – 4–6 yrs old

KIDS – 7–9 yrs old

PRE-TEENS – 10–13 yrs old

TEENS – 13–18 yrs old

ADULTS – 18+

OPEN – Any Age

These are recommended age groups only.

Class placement is advised based on skill level and experience.

If a student is assessed as advanced for their current class, they may be moved to a more suitable Teen, Adult or Open level class.

COMPETITION CREW & TRAINING

Lighthouse Studios offers skill-ready students the opportunity to compete at State and National hip-hop competitions. Dance crews compete under the name "Lighthouse" across divisions including Kids, Juniors, Young Guns, Varsity, Open and JV / Adult Mega crew. We pride ourselves on leading talented and award-winning crews across all divisions. Crew members are expected to be passionate, consistent, positive team players and able to commit to all crew trainings and required regular classes.

CONCERT REHEARSALS:

Lighthouse Studios holds both Mid-Year and End-of-Year Concerts. Compulsory rehearsals are scheduled for all participating classes in preparation for these concerts. Rehearsals are typically held on Saturdays in the weeks leading up to each concert and generally run for 3–4 hours, depending on class requirements. Additional rehearsals or extended rehearsal times may be added when required. This may depend on production needs, class size, choreography requirements or venue scheduling. An additional concert rehearsal fee applies. Rehearsal fees, schedules and durations may vary from year to year. Full rehearsal details will be communicated in advance for each concert period. Attendance at rehearsals is compulsory for all students participating in concert performances. Failure to attend rehearsals may affect a student's participation in the concert.

PERFORMANCE OPPORTUNITIES:

Throughout the year, Lighthouse Studios aims to provide performance opportunities for students. In previous years, students have performed at shopping centres, festivals, expos, charity events and community events. All students are encouraged to participate. If you are aware of an event that may suit our students to perform at, please contact us.

WHAT TO WEAR & WHAT TO BRING:

Comfortable clothing such as loose pants, basketball shorts, leggings, sneakers or runners, and Lighthouse merchandise. No thongs, school shoes, jeans or restrictive clothing are to be worn in class.

What to bring:

Water bottle, towel, and the willingness to be pushed out of your comfort zone!



RULES & REGULATIONS

At Lighthouse Studios, we strive to provide a safe, open and positive environment grounded in love, respect and integrity, where students, parents and visitors feel welcomed, supported and encouraged, and where everyone is free to grow, express themselves and shine.

BEHAVIOUR EXPECTATIONS

All students, parents and family members are expected to be kind, respectful and considerate at all times. This includes showing respect to all teachers, assistant teachers, staff, fellow students and other parents.

Lighthouse Studios has a zero-tolerance policy for bullying or inappropriate behaviour. Any issues raised will be addressed accordingly.

Students are expected to listen to and follow their teacher's instructions at all times. Inappropriate behaviour will not be tolerated and parents or guardians will be notified if required. Lighthouse Studios reserves the right to refuse continued participation for ongoing inappropriate behaviour.

PARENTS & GUARDIANS: DROP & GO SYSTEM

To reduce crowding in the foyer, reception and walkway areas, parents are required to drop their child/ren off 5–10 minutes before class and collect them immediately after class finishes.

Parents are asked not to compare their child to other students. We encourage families to support their child in focusing on their own individual dance journey.

STUDIO RULES

Food and drinks are not permitted in the dance studio, with the exception of bottled water. All bags and belongings must be placed in the cubbies provided.

All Tiny Tots, Kids and Pre-Teen students are required to use the toilet before class to minimise disruptions during lessons. Chewing gum is strictly prohibited in the dance studio at all times.

WALKWAY & STUDIO ENTRY

For OHS and safety reasons, there is no waiting or sitting permitted in the walkway area between the gym and the studio while classes are in session.

VENUE & LOST PROPERTY

There is strictly no access to the gym, as this is a separate business. Gym equipment must not be touched or used unless permission has been given by a faculty leader.

All students, parents and visitors are expected to respect Lighthouse Studios property. Please ensure all rubbish is taken with you and disposed of appropriately.

We strongly discourage bringing valuables to the studio. Lighthouse Studios will not be responsible for any lost or stolen items. All users of the facility are asked to clean up after themselves when using the dance studio, foyer, reception, toilets and driveway areas.

RECEPTION / FOYER / GYM / DRIVEWAY AREAS

The reception area is provided for fee payments, dropping off and picking up children only. Due to limited space, waiting in your car is the preferred option.

Class changeovers must remain smooth, with noise kept to a minimum so students and gym members can concentrate during sessions.

When entering or exiting the venue, please be mindful of neighbouring businesses. There is to be no yelling or running inside or outside the premises.

The driveway speed limit is 5 km/hr. Please drive carefully, as children, adults and parents with prams frequently use this area.





TERMS & CONDITIONS

FEES

Class fees are charged per term and must be paid in full upfront before or within the first week of each term or upon enrolment. Late payments will incur a \$25 late fee per week if fees are not paid by the Sunday of the first week of term, until the balance is settled. No pro-rata fees, credits or discounts will be provided for absences due to illness, family holidays, religious holidays, public holidays, or withdrawal from a class once the term has commenced. If you are unable to meet the payment deadline, you must contact Lighthouse Studios before the due date to discuss alternative payment arrangements. Failure to do so may result in suspension of classes until fees are paid. If a student withdraws or does not return to class, no refund will be offered. Any outstanding concert, competition or costume fees remain payable in full.

REFUND POLICY

If a class is cancelled or postponed by Lighthouse Studios, the class fee will be credited or rolled over at the studio's discretion. Once a term has commenced, no refunds will be issued for term fees or enrolment fees.

Make-up classes are not offered for absences for any reason. Refunds may only be considered if a student sustains an injury that prevents participation for the remainder of the paid term. In such cases, a valid medical certificate from the student's treating physician must be provided. Refunds are calculated from the date the medical certificate is received.

INFORMATION FOR PARENTS

It is the responsibility of parents and students to read all newsletters, notices and communications issued by Lighthouse Studios. Families are encouraged to follow our Facebook and Instagram pages and regularly check the website for updates and announcements. To minimise class distractions and maintain a focused learning environment, parents and spectators are not permitted to watch classes while they are in session, including during crew training.

INJURY / MEDICAL CONDITIONS

Students and parents must notify teachers of any injury or medical condition prior to or during class. All medical conditions must be disclosed before a student commences classes. Parents and students are responsible for informing staff of any medical needs and ensuring required items are brought to classes, rehearsals and performances, including but not limited to asthma puffers, medication or supports. Lighthouse Studios accepts no responsibility for injuries resulting from undisclosed medical conditions.

ANNUAL CONCERTS

All students are expected to participate in Mid-Year and End-of-Year Concerts, unless otherwise advised by Lighthouse Studios. Attendance by parents and guardians is strongly encouraged. Family and friends are welcome to attend and celebrate students' achievements. Backstage access is strictly limited to authorised parents or guardians only, as determined by Lighthouse Studios.

CLASS ATTIRE & RECORDING

All students must wear appropriate dance attire as outlined on Page 3 of this information pack. Photography and video recording are not permitted during classes or dress rehearsals. Video recording is permitted only at the end of class for personal practice purposes. Any unauthorised distribution of footage on social media is prohibited.

CONDITIONS OF ENROLMENT, PERMISSION & INDEMNITY WAIVER

PHOTO & IMAGE RELEASE

I give permission, as a student or as the parent or guardian of my child/ren, for photographs and video footage to be taken and used for promotional and educational purposes. This may include, but is not limited to, newsletters, websites, social media, advertising material, posters, handouts, printed publications, digital media, video productions, photo displays and other promotional platforms used by Lighthouse Studios. These images and videos may be used to promote Lighthouse Studios and its programs now or in the future. No compensation will be provided for the use of such material.

MEDICAL CONSENT

In the event of an injury or accident, I, the parent or guardian, or the student (if 18 years of age or older), give permission for Lighthouse Studios, its owners, operators and teachers to seek medical treatment for myself and/or my child/ren if they are unable to contact a parent or guardian. Where an ambulance or emergency medical treatment is deemed necessary, all associated costs will be the responsibility of the parent or guardian.

HEALTH, SAFETY & GOVERNMENT REGULATIONS

To ensure the safety of all students, staff and families, anyone who is unwell or displaying symptoms must not attend class. Parents or guardians must notify Lighthouse Studios if their child will be absent. All students, parents and visitors must follow any current health, safety or government regulations while attending the studio. Students are required to sanitise their hands before entering class. Parents are not permitted to wait in reception or foyer areas during classes. Drop-offs are to the front door only, with collection immediately after class. Lighthouse Studios is cleaned and sanitised regularly. If classes are cancelled, postponed or adjusted due to health or safety requirements, families will be notified via official studio communication. Please ensure contact details remain up to date. Where required, attendees must sign in or check in as directed. Parents or guardians are responsible for checking in younger students. Due to changing circumstances, classes may transition to online delivery. No refunds will be issued in these situations, as classes will continue in an alternative format.

PARENT / STUDENT ACKNOWLEDGEMENT

By enrolling at Lighthouse Studios, parents, guardians and students acknowledge that they have read, understood and agree to abide by all studio policies, terms and conditions outlined in this information pack.

PLEASE TAKE NOTE OF THE FOLLOWING:

It is compulsory for all crew members to attend an allocated weekly class for upskill and training purposes.

ALL CREW MEMBERS ARE REQUIRED TO PAY THE ANNUAL ENROLMENT FEE - \$65

Term Fees are allowed to be paid in 2 installments for crew training only. 50% of the fee can be paid within the first week of the term and the next 50% by the 5th week of the term however (**THIS DOES NOT APPLY FOR TERM 1**).

THROUGHOUT THE YEAR, EXTRA TRAINING WILL BE AT AN ADDITIONAL COST DEPENDING ON UPCOMING COMPETITIONS/EVENTS

PUBLIC & SCHOOL HOLIDAYS

PUBLIC HOLIDAYS

SCHOOL HOLIDAYS

The training fee over the school holidays will be collected as casual payment. The number of training sessions over the school holidays will be determined by any upcoming dance competition at the time.
